The Fund focuses on grassroots organizing and power building in communities of color who are facing injustice based on racial, ethnic, religious and other forms of discrimination. EF provides resources to defend against the ongoing crisis, and to develop innovative strategies to transform our country. In my role I work to:

- Deepen our practice of solidarity with our partners and soon-to-be partners, ensuring that our work is intersectional, survivor-centered, coalition-led, and people-powered;
- Ensure that our funding model maintains minimal bureaucracy, leaning into the expertise and networks of our decision-making Advisory Council, and funding leadership from the most impacted communities quickly and responsively;
- Communicate about the work of grantees and applicants and lessons learned from the Emergent model with donors to the fund – including members of partner donors networks – other funding partners, and rapid response funds;
- Lead strategy and long-term vision for the Emergent Fund in collaboration with other Fund leaders, community stakeholders and grantees;
- Lead development of funding partnerships for the Emergent Fund, including existing and potential new partners; and
- Shore up grantmaking processes, evaluation, and infrastructure, so that we can continue to meet the needs of our communities for the long haul
